Below are examples of how the current dental climate is affecting professionals today.



According to the BDA, official data shows real incomes for typical dentists have **fallen by up to**40% in the last 10 years.



Nearly **4 in 10 (39%)** said they were likely to retire or leave practice in the next 5 years.



Just over half (52%) said they had reduced their hours to cope with workplace pressures.




The government are **increasing dentistry training** places by 40% by 2031/32.




In support of this, it will **increase training places** for dental therapy and hygiene professionals **by 28%** by 2028/29.




Associate hours preferred


Associate mile radius



38% of Associates will only travel up to 10 miles.


Associate days to work




62% of Associates want private only work or above £12.50 per UDA compared to 49% in 2022.

Associate UDA level






EU Dentist notice period



EU Dentist hours wanted








EU Dentist private remuneration

There's a 28% difference between EU dentists and UK Associates who want 40% private remuneration.












EU Dentist days to work






Foreign Dentist (Non EU) notice period




Foreign Dentist (Non EU) hours wanted


